Future plans August to November 2018

This is at the invitation of an occupational health consultancy, *Fit for Work* and in collaboration with the Royal Australasian College of Physicians and the New Zealand OH Nurses Association. I will present at a conference in Wellington and then deliver lectures for transmission to health care students across several universities in both North and South Islands.

Impact. This will be the first event of its kind. OH Nursing is a very small and niche specialty in New Zealand, opportunities for CPD for OH nurses in particular are infrequent. There will be opportunities to develop links between LSBU and schools of health in a number of universities. There are also issues in relation to student employability. *Fit For Work* is aware of the esteem in which LSBU OH Nursing graduates are held. They wish to explore how graduates from the LSBU programme may gain employment with them on both long and short-term contracts.
